Tuition:

- **Electives and Required hours with Lead (Sarah Woods) are needed to fulfill a 300 hr training to obtain your RYT 500. This is a continuous training with many options for you. We encourage you to spend these hours wisely, devoted to areas of study that speak to your heart.

Please submit for approval:

Certificate of Completion & Portfolio: After CORE hours are completed and portfolio reviewed, a certificate for RYT500 is given.

Portfolio to include: 3 book project workshops, Body of Work, Promotional materials, Video Class, class reflections, Elective hour log & 5 Assistant hours. Students can complete the course anywhere from 10-24 months, working at their own pace.

Pre-Requisites: 200 hr Yoga Alliance accredited certification, a willingness to go deep and a devotion to your life's practice.

Must be prepared to read the following books before/during training: 1. The Bhagavad Gita, 2nd Edition by Eknath Easwaran. 2. The Yoga Sutras of Patanjali by Sri Swami Satchidananda.

Required Texts: (cost not included with tuition) A 3 ring binder, paper, pens, highlighter (3) yogic texts of your choice for the 3 workshop projects Light on Pranayama by BKS Iyengar, The

Tuition includes CORE hours, and 10 classes to attend during the duration of CORE training. There will be required texts that are not included in the cost.

A \$500 non-refundable deposit is required to hold your spot in any session (and will go towards your tuition).

A 3 day cancellation period begins when you pay your deposit to hold your space in the program. In the event of non-acceptance, you will receive a full refund. (A nonrefundable application fee of \$100 is included in your deposit. If you withdraw after the three-day cancellation period and prior to the start of the session, you will be refunded your deposit minus the application fee.)

CANCELLATION AND REFUND POLICY: Rejection: An applicant rejected by the school is entitled to a refund of all monies paid. A minimum of 10 students is required to run the program. In the event of cancellation, a full refund will be given, along with a 6 month discount of 10% to any scheduled electives.

Three-Day Cancellation: An applicant who provides written notice of cancellation within three days (excluding Saturday, Sunday and federal or state holidays) of signing an enrollment agreement is entitled to a refund of all monies paid. The school shall provide the 100% refund (minus \$100 application fee) no later than 30 days after receiving the notice of cancellation.

Other Cancellations: An applicant requesting cancellation more than three days after signing an enrollment agreement and making an initial payment, but prior to entering the school, is entitled to a refund of all monies paid minus the non-refundable deposit.

Refund after the commencement of classes:

1. Procedure for withdrawal/withdrawal date:

A. A student choosing to withdraw from the school after the commencement of classes is to provide written notice to the Director of the Soul Tree Studio YTT. The notice is to indicate the expected last date of attendance and be signed and dated by the student.

B. Students unable to complete the required clock hours have the option to complete these hours (with instructor approval) in future sessions without additional tuition. Certificates will not be issued until program requirements are met.

C. For a student who is on authorized Leave of Absence, the withdrawal date is the date the student was scheduled to return from the Leave and failed to do so.

D. A student will be determined to be withdrawn from the institution if the student has not attended any class for 30 consecutive class days.

E. All refunds will be issued within 30 days of the determination of the withdrawal date.

2. Tuition charges: Tuition charges will be determined based upon the percentage of the clock hours attempted. The percentage of the clock hours attempted is determined by dividing the total number of clock hours elapsed from the student's start date to the student's last day of attendance, by the total number of clock hours in the program (less the \$500 deposit). Tuition refunds will be issued within 30 days of the date of student notification, of date of school determination (withdrawn due to absences of other criteria as specified in the school catalog), or in the case of a student not returning from an authorized Leave of Absence (LOA), within 30 days of the date the student was scheduled to return from the LOA and did not return.
*No refunds for the hours completed.

Special Cases: In case of prolonged illness or accident, death in the family, or other circumstances that make it impractical for the student to complete the program, the school may make a settlement that is reasonable and fair. Soul Tree Studio, LLC reserves the right to discontinue any students' training for unsatisfactory progress, nonpayment of tuition or failure to abide by School rules. 1. Excessive absences or tardiness. 2. Nonconformity of rules and regulations 3. Conduct that is unsatisfactory to staff, faculty, and its students. 4. Breach of Yoga Teacher Training enrollment agreement. 5. Failure to pay fees when due and/or to make available required documents. 6. Entering class while under the influence of alcohol, or drugs. 8. Carrying a concealed or potentially dangerous weapon. 9. Aiding, abetting, or inciting others to commit any act that would detract from the normal operation of Soul Tree Studio. 10. Theft.

Required number of students: Soul Tree Studio, LLC requires a minimum of 10 students to hold the training, and a maximum of 20 students. In the event that less than 10 students register, all monies will be refunded, or can be held for future tuition, upon the choice of each individual student.

Attendance Policy: Students are required to maintain a minimum of 100% attendance over the length of the program. All absences must be pre-approved by the instructor and arrangements made to complete the missed amount of classroom time. Failure to make such arrangements may result in termination. If a student must be absent, he/she must call within thirty (30) minutes prior to class start time.

Tardiness and leaving class early is subtracted from the total time of the program, and counts against the minimum required attendance.

Make-up Work Assignments and projects not completed on schedule during a course must be made-up within the time frame of that course.

Arrangements MUST be made with the instructor.

Grading System Whether the student passes or fails the program is based on completion and participation in all assignments, electives, observations, and performance evaluations given during the course of the program.

Transcripts: Students will receive one free copy of their certificate upon graduation. A fee will be charged for additional copies and must be paid in advance before they are processed.
